Setup: Applicants must bring their own tents, tent weights, tables, chairs and displays. Set up is from 7:00 am to 9:30 am on September 28th. You will receive your booth number and any additional information that morning when you check in at the Flushing Area Chamber of Commerce, located at: 105 E. Main St., Flushing, MI 48433.

Sales Tax: Appropriate sales taxes must be collected and paid by the vendor.

Sales: All proceeds from sales go to the exhibiting vendor.

Liability: Vendors are fully responsible for the care and security of their property. The Flushing Area Chamber of Commerce and the City of Flushing assumes no liability for any loss or damage to vendor's property from any cause.

Exhibit space: Booth space is pre-assigned on a first come, first serve basis. Booth space is 10' x 10' open air. . Vendor to provide own tent, weights, tables, chairs, etc. Electricity is not provided unless a special request is submitted, and then only if available. This is open air space, please be prepared for weather changes, e.g. tent weights, etc. It is the responsibility of the vendor to leave the space in a clean manner.

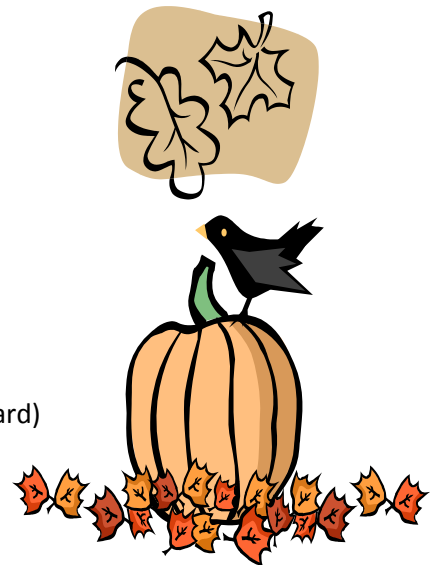


